


In a way, Canada is lucky that the Trudeau government was so slow with the vaccine roll out. We can witness what is happening in countries that rolled out months ahead of Canada. In South Korea, Covid-19 cases are exploding through the roof and hospitals are being over run. The country is over 80% fully vaccinated. The chart below from John Hopkins University data is awful, look at their last peak, a year ago at just 1,132 cases. **What changed since then? Experimental shots**. As usual, people over 60 account for just 35% of the cases but 84% of the critically ill.



South Korea has also imposed a mandatory quarantine of 10 days for all overseas arrivals, regardless of vaccination status.

I have repeatedly commented for many months that we will not see the real test of these experimental shots until this winter (first flu season with shots). We are barely into it and things are trending in a very bad direction. And these shots are not preventing deaths either, see chart next page for South Korea. South Korea is in the Northern hemisphere and similar flu season as here.

We know deaths lag cases by 2 or 3 weeks, so they are going a lot higher, unfortunately.

And I found an update about the FDA release of Pfizer trial data. A judge ordered FDA to release 500 pages per month and since there is well over 300,000 pages it will take about 55 years. On Thursday, Congressman Ralph Norman (R-SC) introduced legislation that would require the Commissioner of the Food and Drug Administration (FDA) to release all records of information submitted to the FDA regarding the authorization of emergency use of, or licensing of all COVID-19 vaccines. The bill requires all records and information to be released to the public no later than 100 days. He is a Republican so will have to persuade many Democrats to get this any where.

I tried a google search to find the 1st 500 page release and nothing came up, another obvious censorship move. I had to use the bing.com search engine and some very bad news is revealed. The FDA's excruciatingly slow release of data related to Pfizer's COVID-19 vaccine has already borne fruit, and it's damning despite a trickle of just 500 pages per month out of 329,000 pages.

<u>As first reported by Kyle Becker</u>, there were a total of 42,086 case reports for adverse reactions (25,379 medically confirmed, 16,707 non-medically confirmed), spanning 158,893 total events. **More than 25,000 of the events were classified as "Nervous system disorders." This is just to end of February 2021.**

As for the volume of reports, in the 2 ½ months following EUA, Pfizer received a total of 42,086 reports containing 158,893 "events." Most of these reports were from the U.S. and disproportionately involved women (29,914 vs. 9,182 provided by men) and those between 31 and 50 years old (13,886 vs 21,325 for all other age groups combined, with another 6,876 whose ages were unknown). Also, 25,957 of the events were classified as "Nervous system disorders"

A long time subscriber sent me this video by Dr. Chris Marten where he has numerous screen shots of the 500 page release data and discusses key info. This data was from just December 1st 2020 until end of February 2021. He shows the 42,086 adverse events and on the same chart 1,223 deaths. Pfizer just reported 1 death when they announced their trial data, but it was just 14 days after the shot. Now we see that after 90 days, the deaths sky rocketed to 1,223. They kept on giving these shots, it is criminal. Among the deaths there was 136 heart related deaths within 24 hours of having the shot.

A lot of immune disorders showed up as well, 1,050 events and showed up less than 24 hours after shots.

What is more criminal is that the FDA had this data and concealed it. You really have to wonder what is going on here.

Informed consent was talked about in this early data release, that should come from a physician to patient. However, we know that most people lined up at temporary clinics like sheep into a coral. They received 'zero' information' on the shots and just agreed to them, based on media propaganda. It is just unbelievable that so many were scared to death to go join this experiment.
