I finally got my hands on the actual data released by the FDA under court order. This is just the first 500 pages and as I mentioned at the rate of 500 pages per month it will take about 55 years. Regardless, this first data release is **both stunning and very upsetting.** The most important data is 38 pages titled " 5.3.6 CUMULATIVE ANALYSIS OF POST-AUTHORIZATION ADVERSE EVENT REPORTS OF PF-07302048 (BNT162B2) RECEIVED THROUGH 28-FEB-2021"

Now keep in mind, the US started the roll out of Pfizer shots on Dec., 14, 2020 and this report is up to the end of February so it involves 2 and 1/2 months and early days with a small fraction of doses compared to today. 
a. in 46 cases reported age was <16-year-old and in 34 cases <12-year-old.

Under gender, note about three times as many females badly affected, no explanation why. Case outcome, as end of February there was 1,223 dead and 520 recovered with sequelae. That means they have a permanent disability or condition. What is more scary, 11,361 not recovered at time of the report (February 28, 2021). Figure 3. COVID-19 cases (n=1,811,673 1) in Canada by date 2 as of December 10, 2021, 7 pm EST (total cases




