### What do Pastors and Ministers know that the government is afraid of? Simple, it is called the truth.



Some simple facts. Although there were 572,982 'cases' in Canada during 2020, the majority were not actually ill or experiencing any symptoms. Rather, these 'cases' refer to people who tested positive on a **PCR test**, the **accuracy of which has been seriously questioned by medical doctors and infectious disease specialists**. Of those Canadians who did show symptoms, most experienced it as a mild or severe flu, and very few required hospitalization.

By March 19, 2021, the total number of positive PCR test results ('cases') had grown to 916,844. Statistics Canada offered detailed information on 71 per cent of these. Only slightly more than seven per cent required hospitalization, and approximately 1.4% of the 916,844 were admitted to ICU. As one would expect, nearly two thirds of ICU admissions were above the age of 60. That means just 12,835 people admitted to ICU in the past year. But you cannot deny that our hospitals were over run. The real issue is that they were over run every flew season before Covid-19, just ask any doctor or nurse that works at one in a big city.

That would mean a swab for a PCR test.

With Drosten PCR tests so far, 2 courts ruled as ineffective to test for the virus. Just a matter of how many court rulings will it take? The old media is pretty much dead. S Korea,	2,589
Australia	1,164
Taiwan	95
China	63

Seems strange that China is so low and that is where it all started. I would not believe anything out of China so will disregard that number. Taiwan and S Korea are neighbouring countries to China and have managed Covid-19 exceptionally well. Taiwan has just 14 deaths and S Korea just 1,904. These are fractions of the **reported** deaths in Canada. S Korea has a larger population than Canada around 51 million and Taiwan lower at 23 million. Both countries acted far quicker than most, starting in January 2020. S Korea developed it's own Covid-19 test and neither country is using the PCR test. **So they are not reporting all the false positive test results that are no help and actually a deterrent to managing Covid-19.** 

It seems some countries, like UK, US and Canada have a strategy of reporting as many positive test results as possible. This is one of many reasons why these countries have so many problems with Covid-19. Australia also has a low case number and from what I can find they are using the PCR test, but they are managing their testing completely different. Australia is only doing targeted testing and no large scale testing. This is their reasoning from their department of health.

Currently, the CDNA, PHLN and the Australian Health Protection Principal Committee (AHPPC) do not support large-scale, non-targeted testing for SARS-CoV-2 in asymptomatic people as part of the public health response. Non-targeted asymptomatic testing is neither epidemiologically sound nor a cost-effective approach to identify disease transmission.11,12 Mathematical modelling shows that testing of non-targeted asymptomatic individuals is not an efficient way to detect community transmission 13. This testing framework outlineswhere asymptomatic testing is best targeted to inform the public health response (Section 5).

### It is not just Canadians that are loosing their rights.

More than 120 retired U.S. generals and admirals signed an open letter warning that the United States is embroiled in an existential fight and urged "all citizens" to get involved in local and state politics.

"We are in a fight for our survival as a Constitutional Republic like no other time since our founding in 1776. The conflict is between supporters of Socialism and Marxism vs. supporters of Constitutional freedom and liberty," states the letter (pdf), which was signed by 124 former military leaders, released by "Flag Officers 4 America."

The letter also posited that opposition to proposed bills and laws that would strengthen election initiatives has troublesome implications.

I saw this news yesterday. Apple has "largely ceded control" of its data centers in Guiyang and the Inner "Mongolia region" to the Chinese government despite CEO Tim Cook previously assuring that data stored within the region would be safe.

Key quote: "Chinese state employees physically manage the computers. Apple abandoned the encryption technology it used elsewhere after China would not allow it. And the digital keys that unlock information on those computers are stored in the data centers they're meant to secure."

It reminds me of the early days before Research in Motion's (Blackberry) decline. China would not allow Research in Motion into China because their Blackbery messenger was too secure. In other words, the Chinese could not monitor it.

**More rights violations.** Defence lawyers are appalled because they cannot get the video evidence that prosecutors are using to arrest and jail so called criminal activity at the January 6th Capital Hill protest. What footage we saw was from cameras at the event posted on youtube. Some commentary on the issue at zerohedge.

So what, exactly, is the government trying to hide? How can activity inside and outside a public building be considered "highly sensitive?" In response to a Freedom of Information Act filing by Judicial Watch, Capitol Police <u>told</u> the group the recordings are not "public records." But of course they are. A security system controlled by a federal agency in a public building paid for by taxpayers to conduct the public business of public officials is most certainly a public record.

Even if legal loopholes allow for such an exemption, the greater public interest should supersede any technicalities. Major parts of the original narrative already have fallen apart, including the story that officer Sicknick was murdered by Trump supporters and the myth it was an "armed insurrection"; the full account of what prompted the killing of Ashli Babbitt by an unidentified Capitol cop is still unknown.

Further, the Biden regime is weaponizing January 6 to hunt down and destroy the lives of people—many of whom committed no violent crimes—anywhere near the building that day. The Justice Department is promising to build sedition cases; Biden's intelligence chiefs are operating outside their authorization in their effort to portray regular Americans as domestic terrorists.
